SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

The Oranjemund Town Council reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing, stamp and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Security/Bid Securing Declaration
- (b) the List of Goods and Price Schedule Section III;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment deemed appropriate.

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Quotations

The Quotation validity period shall be 90 days from the date of submission deadline.

4. Eligibility Criteria

To be eligible to participate in this Bidding, you should attach originally certified copies:

- (a) Originally Certified Copy of the Close Corporation Certificate (issued in terms of Act 26 of 1988) or Founding Statement or any other relevant Company Registration Certificate. These Certificates should clearly indicate the goods/services that the Supplier/Bidder is registered to render;
- (b) Have an original or originally certified copy of a good Standing Tax Certificate from NAMRA;
- (c) Have an original or originally certified copy of Good Standing Certificate from the Social Security Commission;
- (d) have a valid originally certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998;
- (e) have a written undertaking as contemplated in section 138(2) of the Labour Act, 2007

5. Bid Security/Bid Securing Declaration

6. Delivery

Delivery shall be **30** *days* after acceptance/issue of Purchase Order. Deviation in delivery period shall not be accepted/shall be considered if such deviation is reasonable.

 - Provision of signed delivery note;

7. Sealing and Marking of Bids

Bids should be sealed in a single envelope, clearly marked with the Procurement **Reference Number,** addressed to Oranjemund Town Council with the **Bidder's name** and **contact information** at the back of the envelope.

8. Submission of Bids

Bids should be deposited in the Quotation/Bid Box located at Oranjemund Town Council head office, finance building, not later than **9 June 2023**, by **14h00** at latest. Bids by post or hand delivered should reach by the same date and time. Late bids will be rejected. Bids received by e-mail will not be considered.

9. Opening of Bids

Bids will be opened internally by the Oranjemund Town Council immediately after the closing time referred to in instruction 8 above. A record of the Bid Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Security/Bid Securing Declaration, will be posted on the website of the Oranjemund Town Council and available to any bidder on request within five (5) working days of the Opening.

10. Evaluation of Bids

The Oranjemund Town Council shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference of 10% where applicable of total amount including vat & transporting cost, to determine the lowest evaluated quotation.

11. Technical Compliance

Bidders shall submit along with their quotation's documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Oranjemund Town Council's requirements.

The Specifications, Performance Requirements and Compliance Sheet details the minimum specifications of the goods/items to be supplied. The specifications have to be met but no credit will be given for exceeding the specifications.

12. Prices and Currency of Payment

Prices for the supply of machinery shall be fixed in Namibian Dollars as quoted. Quotations shall cover all **costs of materials, transport, overheads, profits and all associated costs for supplying the machinery, and shall include all duties**. The Oranjemund Town Council may allow for prices to be adjustable to change in rates of exchange of currency, price variation etc. depending on the behaviour of the market in respect of the specific goods items being procured.

13. Margin of Preference

- 13.1. The applicable margins of preference and their application methodology are as follows: Margin of Preference where applicable, to be determine as the lowest evaluated quotation of not more than the budgeted amount and not less than 10% of the budget amount, depending on the compared market value of products at that time.
- 13.2. Bidders applying for the Margin of Preference shall submit, **upon request**, evidence of: product price from manufacture or suppliers.

14. Award of Contract

The Bidder having submitted the lowest evaluated responsive quotation and qualified to supply the goods/items and related services shall be selected for award of contract. Award of contract shall be by issue of a Purchase Order/Letter of Acceptance in accordance with terms and conditions contained in Section VI: Contract Agreement and General Conditions of Contract.
